

# **Regulations of the 20th Warsaw Half Marathon**

## **I. The Organizer**

1. The Organizer of 20th Warsaw Half Marathon is Warsaw Marathon Foundation. 15 Brylantowa str., 05-077 Warsaw, registered under Taxpayer Identification Number (NIP) 9521913280 and Business Identification Number (REGON) 015438288, entered into the Register of Entrepreneurs of the National Court Register kept by the District Court for the Capital City of Warszawa in Warsaw under the numer (KRS) 0000152754.

## **II. Date and venue**

1. The Race will take place on 22nd of March 2026 in Warsaw.
2. The Race will start at 11:00 am. The starting line will be closed after around 5 minutes from the start of the last group.
3. The distance of the course is 21,0975 km. The course is approved and certified by Polish Athletic Association (PZLA) and World Athletics.
4. The exact course of the Race will be announced on the website <https://polmaratonwarszawski.com/>. The Organizer has the right to change the course and in such an event, will inform the Participants by posting a new course on <https://polmaratonwarszawski.com/>. Such a change shall not create any additional claims and/or liabilities.
5. Every kilometer of the course will be marked with vertical and horizontal signs.
6. The start area will be divided into pens. Participants shall enter the appropriate pen according to the color of the starting number. The color of the starting number is set on the basis of result declared by the Participant during the registration form. The declared result can be changed until 18th February 2026. The Organizer does not guarantee that the Participants who pay the entry fee after 18th February 2026 will get the pen (and the color of the starting number) in accordance with their declared result.
7. The Organizer has the right to change the start time and in such an event, will inform the Participants by posting relevant information on <https://polmaratonwarszawski.com/>. Such a change shall not create any additional claims and/or liabilities.

## **III. Time limit**

1. The time limit of the Race is 3 hours 30 minutes, counted from the first start signal.
2. Additional time limits are set on:
  - i. 1 hour 12 minutes on the 5th kilometre (from the first start signal)
  - ii. 1 hour 45 minutes on the 10th kilometer (from the first start signal)
  - iii. 2 hours 38 minutes on the 15th kilometer (from the first start signal)
3. The Participants who fail to complete the Race within the time limit or will not cross the lines mentioned in the previous point in the time limit stipulated above are obliged to forfeit and leave the course of the Race.
4. Participants remaining on the route after the specified time limit do so at their own risk and responsibility pursuant to Polish traffic regulations and the Polish Civil Code.

## **IV. Participation**

1. Only individuals who are at least 18 years old or who will turn 18 on the day of the Race, i.e. on 22nd of March 2026, are allowed to participate in the Race (DOB before 22nd of March 2008).
2. In order to participate in the Race each Participant is to undergo identity check in the Race Office or use the option of shipping the Race Kit (regulated in section VI of these Regulations). The identity check in the Race Office can be made:
  - i. in person – on the presentation of a photo ID and a personalised QR code
  - ii. by an authorized person – on the presentation of a personalised QR code and photocopy/photo of the Participant's identity document.
3. QR codes will be sent to the Participants via email and text message on the 19th of March 2025 after 5 pm.

5. The organizer reserves the right to introduce rules regarding the collection of Race Kits at the Race Office, including the requirement for participants to register for specific time slots (day and/or time). Information about such rules will be published on the event website and sent to participants by email.
6. In the Race Office, every Participant will receive an individual Race Kit with, among others, a starting number, timing chip (integrated with the starting number), safety pins, deposit bag and keepsake T-shirt (optional, according to the selected option of Race Kit). T-shirts in the Race office will be distributed pursuant to the previous declaration of Participants. T-shirt size shall be chosen in the application form. Change in the size will be possible in the application form but not later than on 18th of February 2026. The number of T-shirts in each size is limited and the availability of each size is not guaranteed.
7. Race Kits not collected in the Race Office will be neither sent nor distributed in any other way at a later date.
8. During the Race, all Participants shall have their starting number horizontally attached to the front of their Race tops (alternatively, sweatshirt or jacket). The starting number shall be visible during the whole race. Covering (in part or in whole during the whole Race or its part) or modification of the starting number is forbidden under the penalty of disqualification. The timing chip is integrated with the starting number. Tampering with the timing chip (folding, unsticking, etc.) or placing the bib number in a place other than horizontally in front of the chest may result in the timing chip not working properly and, therefore, no result being recorded.
9. Participation without a valid starting number is forbidden.
10. Transferring your starting number to another person is prohibited and will result in a 3-year disqualification of the person registered for all events organised by the Warsaw Marathon Foundation.
11. The Organizer allows the start of Participants on wheelchairs with direct manual drive. After filling in the application form where they declare the will to start on a wheelchair, the Participant shall send an email to [info@warsawmarathon.com](mailto:info@warsawmarathon.com) with a document proving their disability attached – it is a condition for granting a 50% discount of the entry fee

(Race kit without T-shirt). It is not allowed to start on wheelchairs: with indirect drive (e.g. handbike) or rim-push type. Participants on wheelchairs must complete the entire course of the Race on their own, without the help of others.

12. Participants of the Race are obliged to follow these Regulations of the Race, and rules of PZLA and World Athletics.
13. In accordance with the recommendation of the Ministry of Sport and Tourism of July 20, 2022, Participants representing Russia and Belarus are excluded from participation in the 20th Warsaw Half Marathon. The exceptions are Participants of Belarusian nationality who permanently reside in Poland and will send a scan of the [DECLARATION](#) to [info@warsawmarathon.com](mailto:info@warsawmarathon.com). The Declaration confirms that:
  - i. they do not represent the Russian or Belarusian state;
  - ii. they do not receive funding from sources linked to the Russian or Belarusian state, including from sponsors controlled by individuals or entities subject to European Union sanctions;
  - iii. they do not express support for the invasion of Ukraine, the Russian or Belarusian authorities, or their leaders.

Failure to submit the required declaration will result in non-admission to the race, and the entry fee will not be refunded.

Participants representing Russia and Belarus who, while registering, will deliberately declare a nationality different than their own will not be allowed to participate and the entry fee will not be returned.

14. The Organizer provides medical care on the starting line, along the Racecourse and on the finish line.

## **V. Registration**

1. In order to register for the Race one shall fill in the registration form available at <https://polmaratonwarszawski.com/> and <https://rejestracja.maratonwarszawski.com/>.
2. Registration is considered to be complete when following conditions are met: application form is filled in and the entry fee payment is credited to Organizer's account.
3. It is possible to register for 20th Warsaw Half Marathon by choosing one of two paths:
  - i. traditional path – filling in the registration form available on event's website and settling the entry fee.
  - ii. charity path – taking part in the charity action #IRunWell regulated in Appendix 1 of these Regulations.
4. Registration will be carried out in the following stages:
  - i. from 12th of November 2025 to 18th of February 2026 – open registration in the traditional and charity path;
  - ii. from 19th of February 2026 to 22nd of March 2026 – open registration only in the traditional path.

**Registration will be closed earlier if the limit of Participants is reached (point V.5).**

5. The limit of Participants in the Race is set at 20 000 Participants in the main Race.
6. If the limit of registered Participants is reached before the 18th of February 2026, a number of additional places will be available in the charity path. The individuals who created a fundraiser, did not raise the minimum fundraiser sum, and did not register via the traditional path will be allowed to restart their fundraiser. The limit of the additional available places is set at 200 Participants, and the Participants will be assigned a starting number based on the order of raising the minimum sum.
7. The Organizer reserves the right to change the abovementioned limits.
- 7a. Pursuant to clause V.7 of the Regulations, as of 2 January 2026, the Organizer increases the limit of participants in the main race by an additional pool of 5,000 places, i.e. to a total limit of 25,000 participants
8. Online registration will be closed on the 21st of March 2026 at 7 pm. Signing up for the Race will be also possible in-person at the Race Office of the 20th Warsaw Half Marathon, provided that the limit of Participants indicated in point V. 5. is not reached and with the reservation that the total pool of starting numbers for those who register after the 20th of March 2026 and are available at the Race Office is 200.
9. The Organizer reserves the right to close the registration before the abovementioned date if the limit of Participants indicated in point V. 5. is reached prior to it.

## **VI. Shipping the race kit**

1. The Participants of the 20th Warsaw Half Marathon may use the option of Race Kit shipment.
2. The shipment of the starting package consists of sending a parcel via a courier company to the address indicated by the participant, in accordance with the principles set out in the Regulations for the provision of domestic transport and postal services of the courier company.
3. The Race Kits will be shipped only within Poland.
4. The shipment of the Race Kit includes shipping of the starting number, timing chip (integrated with the starting number), safety pins and a commemorative T-shirt – according to the selected Race Kit option). Additional marketing freebies provided by the Event's sponsors are not included in the shipment of the Race Kit. Those will only be distributed when picking up the Race Kit in the Race Office.
5. The shipment of the Race Kit is an additional fee option. The fee for sending a Race Kit is PLN 35 / EUR 10 (gross) for one Participant. Race kits are sent individually, and it is impossible to send more than one Race Kit in a single shipment.
6. Ordering and paying the option of shipping the Race Kit is possible until the 18th of February 2026.
7. The condition for shipping the Race Kit is having a starting number (sent after the entry fee is credited) not later than on the 18th of February 2026.
8. The shipments will take place about two weeks before the Race. In the event of not receiving the delivery until the 15th of March 2025, the Participant shall report this fact to the Organizer at [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com).
9. The Participant using the shipment option is not required to be verified at the Race Office.

## **VII. Entry fees**

1. Each Participant of the 20th Warsaw Half Marathon bears the cost of the entry fee. The exception is the Participants of the #IRunWell charity program, who are subject to the procedure described in Appendix 1 of these Regulations.

The basic rates during open registration are as follows:

1a. In connection with increasing the original limit of participants in the main race beyond 20,000 persons, as referred to in clause V.7a of the Regulations, the Organizer introduces

an additional pool of starting places, for which separate entry fee rates apply, regardless of the registration date. The applicable entry fee for places from the additional pool is determined by the order of registration, not by the date of submission of the application or payment.

1b. For participants registering after the limit of 20,000 registered participants has been exceeded, and until the number of 24,000 registered participants is reached, the entry fee is 75 euro.

1c. For participants registering after the number of 24,000 registered participants has been reached, and until the maximum limit of 25,000 participants is exhausted, the entry fee is 90 euro.

2. The Participant also has the possibility to order additional options and services, the prices of which are:

3. Discounted entry fee during open registration for Polish citizens and residents are as follows.

4. The Participant also has the possibility to order additional options and services, the prices of which are:

5. The number of T-shirts is limited. If a Participant has chosen in the application form a T-shirt but did not pay the fee within 7 days of registering and the number of available T-shirts is low, the Organizer reserves the right to delete selected (unpaid) T-shirts from the registration form.
6. If the payment is made in an insufficient amount (e.g. as a result of exceeding the deadlines listed in the Regulations), the remaining difference to the amount of the

applicable entry fee according to the date of the last transfer must be paid by the Participant - the final payment of the entry fee must be made in accordance with the entry fee at the time of the payment.

7. Entry fee may be settled by online payment (from the application profile) via <https://www.payu.pl/> PayU S.A. is responsible for the settlement and safety of transactions, with the registered office in Poznań, 60-166 Poznań, at ul. Grunwaldzka 182, having tax identification number NIP: 7792308495, REGON 300523444, a domestic payment institution supervised by the Polish Financial Supervision Authority, entered into the Payment Services Register under number IP1/2012. PayU REGULATIONS.
8. For people born on the 22nd of March 1961 or earlier, the Organizer grants a discount on the entry fee in the amount of 25% of the basic entry fee (kit without T-shirt) applicable at the time of entry fee settlement.
9. For Participants starting on wheelchairs, the Organizer grants a discount on the entry fee in the amount of 50% of the basic entry fee (kit without T-shirt) applicable at the time of entry fee settlement. The obligatory condition is to email [info@warsawmarathon.com](mailto:info@warsawmarathon.com) with the document proving disability attached.
10. As soon as the entry fee is credited to the bank account of the Organizer a Race number will appear on the start list at <https://polmaratonwarszawski.com/> next to the Participant's name. If the starting number does not appear within 7 days from the day of the money transfer, the Participant is obliged to contact the Organizer via (+48 22) 266 21 00 or [info@warsawmarathon.com](mailto:info@warsawmarathon.com)
11. The Organizer is not liable for the loss of a registration form, money order or bank transfer by the fault of the post office or a bank.
12. Based on Article 38 point 12 of the Act on Consumer Rights (Journal of Laws of 2020, item 287), Participants who are consumers within the meaning of Article 221 of the Polish Civil Code, have no right to withdraw from the contract.
13. The entry fee, once paid is non-refundable, non-transferable to another Participant, non-transferable to another event organized by the Warsaw Marathon Foundation and non-transferable onto a voucher.
14. The organizer anticipates the possibility of introducing an additional feature in the registration system, enabling a one-time transfer of a race number to another participant for an additional fee once the starting slot limit is reached. The final decision to enable this feature will be made and announced by the organizer at a later date.
15. During registration, Participants have the possibility to order and pay an additional option: „Possibility of resignation from start and cash-back”. In that case, the Participant has the option to resign from taking part in the Race without a reason and receive a 100% refund of the paid entry fee (including additional options). The condition for using the purchased option is to notify the will to resign from the start no later than the 18th of March 2026 (in the case of collecting the Race Kit at the Race Office) or by the 18th of February 2026 (in the case of using the shipping of Race Kit option). The cost of the service is PLN 39 / EUR 10 and is non-refundable (also in the case of resignation from the start).
16. Resignation indicated in point VII. 15. should be made by log-in into the Participant's account on the <https://rejestracja.maratonwarszawski.com/> and selecting the “Resign from Race” button in the YOUR EVENTS tab.

17. Refund indicated in point VII. 15 covering full amount of the entry fee and the purchased additional services (except for the „Possibility of resignation from start and cash-back”) will be made within 21 days, using the same payment method as the fee was paid. Refunds shall not apply to entry fees paid using the “promotional code”.
18. Participants who want to receive an invoice for the paid starting fee should select the appropriate option in the registration form and enter the required data needed to issue the document. The invoice will be generated automatically after the payment has been credited and will be made available for downloading from the Participant’s profile by the 15th day of the month following the month in which the payment took place.
19. In accordance with tax regulations, due to making a payment before the service is performed, an advance payment invoice will be issued covering the full amount of the payment made. Thus, the advance payment invoice is also the final invoice.
20. By selecting the Invoice option, the Participant agrees to send/share invoices in electronic form without the recipient’s signature. This consent does not exclude the Organizer’s right to issue and send invoices in paper form.
21. To receive a pro forma invoice, please send: the invoice data, the number and the list of Participants (with the registration numbers) together with the information about the chosen option of the Race Kit to [ksiegowosc@maratonwarszawski.com](mailto:ksiegowosc@maratonwarszawski.com). Pro forma invoices are issued for the participation of at least two Participants (there is no possibility of receiving a pro forma invoice for the participation of a single person).

### **VIII. Deposits, refreshment**

1. Participants will receive a special deposit bag in the Race Kit, allowing them to leave their deposit in a special deposit area. The deposits will be given back only on the basis of the starting number. In case of a lost starting number, the Organizer is discharged from any liability for giving the deposit to someone else. Note! It is forbidden to leave valuable objects and documents in the deposit.
2. Participants will have the option to use changing rooms and deposit points before and after the race.
3. Participants ave the possibility to use refreshment points along the course and to receive a regeneration package after the finish line (water and meal).

### **IX. Refreshment points and time splits**

1. Refreshment points with water will be located every 4 km starting from the 5th kilometer. There are four refreshment points along the course.
2. The Organizer does not take any personal dietary supplements from Participants.
3. Portable toilets are located near each refreshment point.
4. Time splits will be taken at kilometers 5, 10, 15 and 20 kilometers.
5. The staff working at time splits notes down starting numbers of Participants taking shortcuts. Participants who take shortcuts or change the course will be disqualified.

### **X. Classifications and results**

1. The following classifications will be held during the 20th Warsaw Half Marathon:
  1. General
  2. General for men and general for women
  3. Age classifications for men and women:
    - F-20 / M-20 (age group 1997-2008)
    - F-30 / M-30 (age group 1987-1996)

- F-40 / M-40 (age group 1977-1986)
- F-50 / M-50 (age group 1967-1976)
- F-60 / M-60 (age group 1957-1966)
- F-70 / M-70 (age group 1947-1956)
- F-80 / M-80 (1946 and over)

4. Team classification

5. Branch classification (with the division for men and women) – a Participant may choose only one of the classifications that he/she wants to take part:

- academic – students
- academic – lecturers
- bank employees
- journalists
- FMCG merchants and manufacturers, restaurant owners
- educational institutions employees
- lawyers
- medical services
- military services
- insurance institutions employees
- civil servants
- employees of companies from the medical products industry
- Polish army
- online creators

6. Classification of Participants on wheelchair with direct manual drive (Participants on wheelchairs are excluded from other classifications)

2. Electronic time measurement is the basis of classification. Special measuring mats, which will indicate the presence of the runner in the place, will be placed along the course. In the event where the Participant is not indicated by given time measuring mat, they may be disqualified.
3. The general classification is based on real time (net – measured from crossing the starting line). The exception is the first 200 Participants crossing the finish line – they are classified on the basis of official times (gross – gun), provided that if within the first 200 people at the finish line there are at least 10 men and 10 women, if not the number of 200 people will be enlarged to meet this requirement. All additional classification (age, branch) is based on real time (net – measured from crossing the starting line).
4. Every Participant will receive information about both gross and net times in final results.
5. Unofficial results will be posted on <https://polmaratonwarszawski.com/> just after the Race.
6. The results of branch categories will be posted on <https://polmaratonwarszawski.com/> in three days after the Race.
7. Written complaints about the results can be sent to [info@warsawmarathon.com](mailto:info@warsawmarathon.com) until the 24th of March 2025, 6.00 pm. The complaints will be considered within 96 hours, and final and official results will be announced by the 10th of April 2026.
8. The certificate of completion for the 20th Warsaw Half Marathon will be available for self-printing on the website [polmaratonwarszawski.com](http://polmaratonwarszawski.com) no later than 21 days after the event.
9. The Organizer reserves the right to introduce additional categories.

## **XI. Prizes**

1. Every finisher of 20th Warsaw Half Marathon will receive a finisher's keepsake medal at the finish line.
2. The finishers of places 1-3 in general categories for men and for women as well as the finishers of places 1-3 in age categories, will receive keepsake trophies.
3. The Organizer may offer other trophies and prizes in categories of their choice.
4. Prizes not claimed on the day of the event will only be available for claim until 29th of March, 2026.

## **XII. Personal data protection**

1. Personal data of Participants will be processed in accordance with the applicable provisions, in particular, Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).
2. Processing of data indicated in point XII.1. also includes the publication of: name, surname, date of birth, city and name of the club.
3. Detailed information about the processing of personal data is included to Appendix 2 to this Regulation.

## **XIII. Final Provisions**

1. Any complaints must be made by the Participant within 7 days from the date of receiving the Race Kit. Participant, after receiving the Race kit, should check whether it is complete. The Participant will receive a response to the complaint immediately, no later than within 30 days of its submission.
2. Staying on the 20th Warsaw Half Marathon route without a valid start number is prohibited. People without valid start numbers will be removed from the route by the service staff of the run. No inline skates, bikes, nordic walking sticks or other devices are allowed without the Organizer's permission. Running with dogs is also prohibited. Only vehicles of the Organizer with valid passes issued by the Organizer have access to the route (bicycles, motorcycles, cars).
3. In order to obtain individual consent for a start with a pram, the Participant shall send a scan of his/her STATEMENT to [info@warsawmarathon.com](mailto:info@warsawmarathon.com) and deliver the original to the Race Office by the Race Kit collection.
4. During the Race Participants shall obey orders given by services responsible for safety, emergency services and other staff members appointed by the Organizer.
5. The Organizer assures personal accident insurance during the Race (insured up to PLN 10,000).
6. Every Participant is obliged to get acquainted with the rules and regulations of the Race and accept them. By accepting the regulations the Participant agrees to receive first aid by medical and paramedical services and for medical treatment and the transportation of the Participant to safe place in case of emergency by services approved by the Organizer.
7. The Participant declares that they are able to take part in the race and that they have no knowledge of any reasons connected with their state of health that could exclude them from participation in the Race and that they take part in the Race on their own responsibility. The Participant notes that participating in the run is connected with physical effort, natural risk of accident, body injury and physical trauma (including death)

and material loss. Additionally, other unforeseeable risks can occur. Accepting the terms and conditions of the regulations and rules of the Race means that the Participant considered all the risks connected with the run and will start the run on their own responsibility. All the decisions made by medical service during the Race about the continuation of the Race by the Participant are final and binding.

8. After the race, random doping controls will be conducted, and the Participant designated by the Commission must absolutely submit to them.
9. By signing up to participate in the Race, the Participant accepts these Regulations and agrees for the free use of his image in the form of photographs or video recordings, and grants the Organizer free of charge license to use it in all fields of use, including printing/saving and spreading in any form and keeping in computer memory; to use it for promotion of the events organized by Warsaw Marathon Foundation; to share it with sponsors and partners of Warsaw Marathon for their promotion in the context of participation in the event; to post and publish it in the publications of Warsaw Marathon Foundation and on promotional printed materials of the Organizer, in press, on websites and in television and radio programs.
10. The Organizer reserves the right to cancel, postpone or stop the Race without justification.
11. Placement of advertisement materials on the elements of event infrastructure (i.e. fences, gates etc.) constitutes an exclusive right of the Organiser and is reserved especially for the official sponsors/partners of the Race. It is not allowed to place any advertising medium along the course of the Race and in the areas used for the organisation of the event (e.g. starting line zone, runner's village) without prior consent of the Organiser.
12. Only the Organizer of 20th Warsaw Half Marathon has the right for binding and final interpretation of these regulations. The Organizer makes final decisions in matters not stipulated in these regulations. If any of these regulations are considered fully or in part as invalid or impossible to execute the rest of the regulations will stay (fully or in part) valid.
13. Participants and other people staying in the event area are prohibited from behaviours that call for violence and for wearing and presenting symbols that call for aggression or support warfare. People breaking the ban will be removed from the route and event area.
14. The Participant and the Organizer will strive to resolve any disputes arising between them in an amicable manner, in particular it is possible to use mediation.

**Regulations of the #IRunWell Campaign**

1. Participants, at the time of registration for the Race, are required to choose one of the available registration options:
  1. Traditional registration – by filling out the registration form available on the event's website and paying the required entry fee.
  2. Charity – by participating in the #IRunWell campaign, which is governed by these regulations
2. To participate in the #IRunWell campaign, you need to::
  1. select the "charity registration path" in the Race registration form
  2. select a charitable cause to which the collected funds will be donated. You can choose from 13 available charitable organizations: Rak'n'Roll Foundation – Win Your Life, Amnesty International Association, Give Children Strength Foundation, Synapsis Foundation, Premature Foundation – Parents to Parents, Spartans for Children Foundation, Polish Humanitarian Action, Foundation "For the Rescue of Children with Cancer," DKMS Foundation, Faces of Depression Foundation, Avalon Foundation, Cancer Fighters Foundation, Red Noses Foundation;
  3. complete the required information on the fundraising profile (the page that will be visible to all users on the website and through which support for the fundraising campaign can be provided).
  4. complete the standard Race registration form (declared time, additional classifications, etc.)
  3. After completing the registration, the Participant receives an email with a link to their individual page – the fundraising profile.
  4. Participants who collect at least 450.00 PLN in their fundraising account by the 18th of February 2026, will be assigned a starting number for the 20th Warsaw Half Marathon. The cost of participation is covered by the supported charitable organization.
  5. The start number obtained in this way, along with the charity starter pack for the 20th Warsaw Half Marathon, is non-refundable and cannot be transferred to another Participant or another race.
  6. Fundraising campaigns for individuals who have not collected the specified amount by the 18th of February 2026, will end on that date, and the funds raised will be distributed according to point 8 of these regulations.
  7. Fundraising campaigns for individuals who have collected the amount specified in point 4 of the regulations (or exceeded it) will continue until the 31st of March 2026.
  8. The collected funds, after deducting costs and fees (related to online payments), are distributed:
    1. 90% of the collected amount is transferred to the account of the chosen charitable organization

2. 10% of the collected amount is allocated for the maintenance and development of the #IRunWell initiative and the statutory objectives of the Warsaw Marathon Foundation.

This distribution occurs regardless of the amount raised and whether the goal specified in point 4 has been achieved.

9. By registering for the #IRunWell initiative, the Participant agrees to transfer the funds they have raised to the account of the charitable organization of their choice, in accordance with point 8 of the regulations.
10. Before fundraising the minimum of 450.00 PLN, the Participant can withdraw from continuing the fundraising and transfer their registration from the "charity path" to the "traditional path" by selecting the appropriate option in their profile on the website <https://rejestracja.maratonwarszawski.com/>. The funds collected up to that point will be transferred to the designated organization, in accordance with point 8.
11. A Participant in the #IRunWell initiative who has received the start number mentioned in point 4 can order a T-shirt, medal engraving or Race Kit shipment in accordance with the regulations of the 20th Warsaw Half Marathon
12. Participants in the #IRunWell initiative are subject to the regulations of the 20th Warsaw Half Marathon.
13. As part of the #IRunWell campaign, a symbolic award ceremony will be held for individuals who have raised the highest amounts.
14. Each organization will single out one person who, on the 21st of March 2026 at 12:00 PM, has collected the highest total on behalf of that organization. This may be a participant of the 20th Warsaw Half Marathon or the New Balance 5K Run.
15. The ceremony will take place on 22nd of March, 2026 on the main stage of the 20th Warsaw Half Marathon.

## **Appendix No. 2 to the Rules and Regulations of the 20th Warsaw Half Marathon**

### **Rules and Regulations of the Team Competition within the 20th Warsaw Half Marathon**

1. The team competition is open to teams representing sports clubs, companies, institutions, other organizations, as well as groups of runners competing under a common name.
2. A team consists of 4 members, including at least one woman and at least one man.
3. All athletes who are members of teams are subject to the Rules and Regulations of the 20th Warsaw Half Marathon. Each participant may represent only one team.
4. Each team is represented by its captain. The captain is the only person who:
  - o registers the team for participation in the team classification,
  - o decides on the team composition,
  - o represents the team,

- o communicates with the race organizers.
5. The team's final result is calculated as the sum of the finishing times of all 4 team members, including at least one woman and one man. The team with the lowest total time wins.
  6. Only participants who have been assigned a race number may be registered for the team classification.
- The final deadline for team registration is March 19, 2026, at 11:59 p.m.
7. Any participant with an assigned race number for the Warsaw Half Marathon may act as a team captain.
- The captain registers the team via their account in the registration panel (<https://rejestracja.maratonwarszawski.com/pl/>). The captain is also entitled to make changes to the team composition. Registrations and changes are possible until March 19, 2026, at 11:59 p.m. After this date, no changes to the list of registered teams or their compositions will be allowed.
8. The team classification is conducted as a general classification. No age categories are applied. The Organizer reserves the right to create internal classifications within the team competition.
  9. In order for a team to be classified, all team members must complete the half marathon.
  10. In the event that more than one team achieves the same total time, the final ranking will be determined by the finishing time of the team's best individual runner.
  11. The top three teams in the team classification will receive trophies.
  12. All participants in the team classification who complete the Warsaw Half Marathon are entitled at the finish line to the same medals and benefits as participants registered solely in the individual competition.
  13. The binding and final interpretation of these Rules and Regulations rests exclusively with the Organizer of the Warsaw Half Marathon. Any matters not covered by these Rules and Regulations shall be decided by the Organizer.

**Appendix 3 to  
Regulations of the 20th Warsaw Half Marathon**

**Regulations for the Transfer of a Starting Slot**

1. The Organizer allows the transfer of a starting slot to another person exclusively through the official registration system: <https://rejestracja.maratonwarszawski.com/pl>
2. The cost of transferring a starting slot is PLN 49. The transfer fee is paid by the person transferring the starting slot and is non-refundable, regardless of the reasons for not using the starting slot.
3. The person taking over the starting slot assumes the entire contents of the cart, including all options and additional services. After a successful transfer, it is not possible to change the contents of the cart.

4. The starting slot transfer service may be used until 18 March 2026, or until 18 February 2026 in the case of a purchased shipment of the race package.
5. A transfer added to the cart but not paid for will be automatically removed from the cart after 24 hours.
6. The person taking over the starting slot will receive a new bib number, assigned to the last starting time zone, regardless of the bib number and zone of the person transferring the slot.
7. A starting slot transfer is considered effective only after it has been correctly completed and paid for in the registration system.
8. The person taking over the starting slot bears full responsibility for the accuracy of the provided personal and address data. The Organizer shall not be liable for the consequences of providing incorrect or incomplete data.
9. The person taking over the starting slot declares that they meet all participation requirements specified in the Regulations, in particular those relating to health condition and physical preparation.
10. The entry fee originally paid for the starting slot is non-refundable after the transfer, regardless of the reasons for not using the starting slot.
11. The Organizer shall not be responsible for the unofficial transfer of race packages, in particular outside the registration system, nor for any claims arising from such actions.
12. Any unofficial forms of transferring starting slots are prohibited and are not subject to complaints or claims against the Organizer.

**For what purpose and on what basis are your personal data processed?**
